**Name of the Society**

1. The name of the Society shall be "S.T.S. EDUCATIONAL & WELFARE SOCIETY" Village: Nandpur Kalour (Bassi Pathatanan) Fatehgarh Sahib

**Registered office**

2. The office of S.T.S. EDUCATIONAL & WELFARE SOCIETY" is situated at Village: Nandpur Kalour (Bassi Pathatanan) Fatehgarh Sahib

**Aims and objects**

a. (a) The aim and objects for which Society is established are to establish, run, support, manage schools, colleges or other educational institutions and other financial assistance to schools, colleges, libraries, reading rooms, laboratories, research and other institutions of the like nature in India, for use of the students and staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.

(b) To promote social welfare such as by providing/arranging free education to poor people and promote education, sports, and cultural activities in Punjab.

(c) To run / manage schools, colleges or other educational institutions and organise educational camps in rural area of Punjab.

(d) The Society may perform all such acts as considered necessary or conducive to attainment of the aforesaid objects.

**Income and assets**

4. All the income and assets, both movable and immovable, of the Society shall be utilised by the Society only for the promotion and achievement of its aims and objects as set out in this Memorandum of Association and no portion thereof shall be paid directly or indirectly by way of dividend, bonus, profit or any other manner to any present or past member of the Society or to any person claiming through any one or more of them.
